Congratulations and thank you for considering CRC Christian Church Cape Town for your wedding ceremony.

To consider your request, we will need a minimum time of 4 to 6 months notice of your wedding date. Also note that we will not process your application to be married without the supporting documents! Pls ensure all supporting documents is submitted no later than two months before the wedding date. See next pages in order to know that your documents will be accepted by the Department of Home Affairs.

It is important that you return the application at once, in order for us to save the date that you have in mind. Your zone Pastor will be assigned to marry you and we do require that you are a committed member of CRC and planted in a Homecell. Reservations are not final until feedback regarding the completed forms are filed and confirmed with an email sent by the Church Office. Dates without the application cannot be held. We receive many wedding inquiries every year, and in some cases the wedding dates surpass. In this case, we will contact you to let you know who can do your wedding.

As soon as your wedding date is confirmed, meetings are required for pre-marital counseling. If your wedding date falls between Jan-Jun and Jul-Dec, 5-week, back-to-back scheduled counseling sessions for all will be held respectively, based on the 6-month period you fall under. Dates and times will be communicated to you. One-on-One sessions with your respective pastor will held closer to your wedding date.

- X4 ID copies sent to secretary (couple and their two witnesses). Pls bring original ID's along on the day of signing the register.
- 3 x ID photos of each of the couple
- Lawyers letter sent to secretary (if applicable)
- Cell numbers of witnesses captured on application form
- R200 to office cash only (bring on the day of signing the register)
- Pastor conducting ceremony (planned honorarium at own discretion)
- Pre-marital course complete and one one-on-on counselling session complete

Home Affairs require the following information to be added to the marriage register.

Take note: All documents to be handed in 4 weeks before the wedding date!!!

1. **3 ID photos** of the husband. (Size must be 35 – 40mm in width)
 2. **3 ID photos** of the wife. (Size must be 35 – 40mm in width)
 3. Your **left hand thumb prints** will be taken from both parties.
 4. **Copy** of ID document of the husband. (If no ID Copy is available please contact Home Affairs)
 5. **Copy** of ID document of the wife. (If no ID Copy is available please contact Home Affairs)
 6. **Certified copy** of divorce order, if applicable.
 7. **Certified copy** of death certificate, if applicable.
 8. If you want to get married **out of community of property**, you must go to your **attorney** to obtain a **marriage contract before you get married.**
Certified copy of letter from your attorney, if you marrying ANC (No letter means you will automatically be registered as being married “In community of property”, which has to be changed through a legal firm again, if you should want to do this.

 13. **Foreign wedding:** All foreign persons must please inquire about list of documentation required for application to be processed successfully with Home Affairs.
 14. **R200** Admin fee for Home Affairs arrangements.
